#### Opinion

We have audited the accompanying Statement of Standalone Financial Results of HEXA TRADEX LIMITED ('the Company') for the quarter ended March 31, 2022 and year to the date for the period from 1<sup>st</sup> April 2021 to 31<sup>st</sup> March 2022 ("the statement"), attached herewith, being submitted by the Company pursuant to the requirement of Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended ("the Listing Regulations").

- (b) The audit of standalone quarterly and year to date financial results for the period ended 31<sup>st</sup> March, 2021, included in the Statement was carried out and reported by N.C. Aggarwal & Co., Chartered Accountants who have expressed unmodified opinion vide their audit report dated 25<sup>th</sup> June, 2021.
- (c) We have issued an audit report dt. 26<sup>th</sup> May 2022 (' the original report') on the financial results adopted by Board of Directors on that date. As informed to stock exchanges by the Company in their letter dated 27<sup>th</sup> May 2022, on observing inadvertent clerical error in Cash Flow Statement which was approved by the Board of Directors, the financial results and Cash Flow Statements have been revised and adopted by the Board of Directors. This Audit report supersedes the original report and the revision made are not material considering the size and the nature of the items revised.

Our opinion is not modified in respect of above stated matters.

   However, the Company will continue to closely monitor any material changes arising of future economic conditions and impact on its business.
- 3. The figures of the quarter ended March 31, 2022 and March 31, 2021 are the balancing figures between the audited figures in respect of the full financial year and the published unaudited year to date figures up to third quarter of the respective financial year which were subject to limited review by the auditor.
- 4. An Initial public announcement made by the promoter group persons / entities in accordance with Regulation 8 of the Securities and Exchange Board of India (Delisting of Equity Shares), 2021, inter alia, expressing the intention to voluntary delist the equity shares of the Company and approved to initiate the process and the floor price and notice of postal ballot. The shareholders of the company had also approved the delisting of shares of the company. The in-principle approval from the Stock Exchanges are pending.
- 5. Previous quarters/periods figures have been regrouped/rearranged, wherever considered necessary to conform to current quarter and year ended classification.
- 6. The Board of Directors in their meeting held on 26th May 2022 had approved the financial results which was declared to the Stock Exchanges on the same date. Post submission of results to the Stock Exchanges, an inadvertent clerical error, the impact of which is not material, was observed in the financial results which has been corrected in these results.
- 7. These revised results are reviewed by the Audit Committee and approved by the Board of Directors in their meeting held on May 30, 2022.
